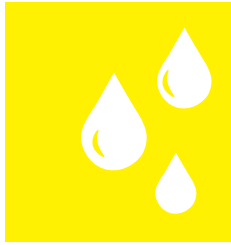

MIXING AND LOADING DIRECTIONS

(Agitate gently before use):

FOR MIXING WITH MELTED UREA:

Nutrex-M/F™ should be added to the melted urea solution at rates ranging from 1.0 to 2.2 oz per 2.17 lb of urea (1 lb N) and mixed thoroughly by agitation prior to adding other nutrients, pesticides, or surfactants.

After donning proper personal protection (recommended long sleeves, long pants, goggles, and natural or butyl rubber gloves while handling the concentrate), fill spray tank half full with melted urea. With agitators on, add the appropriate amount of **Nutrex-M/F™** for the desired concentration in the full volume, mix well and then add the remainder of the melted urea. **Nutrex-M/F™** can be added to melted urea and stored for up to 12 weeks before application without affecting performance.

Nutrex-M/F™, in melted urea, is compatible with most pesticides. However, compatibility testing should take place prior to use.
